# Oregon Medical Board BOARD ACTION REPORT February 15, 2013

On January 24, 2013, the Board issued an Order of License Suspension to immediately suspend Licensee's podiatric license due to his failure to pay child support. Automatic suspension is required by ORS 25.750.

On February 4, 2013, the Board issued an Order Terminating Order of License Suspension. This Order terminates Licensee's January 24, 2013, Order of License Suspension.

On February 7, 2013, the Board issued an Order of License Suspension to immediately suspend licensee's medical license due to his incarceration in a penal institution. Automatic suspension is required by ORS 677.225.

9	The Oregon Medical Board (Board) is the state agency responsible for licensing,		
10	regulating and disciplining certain health care providers, including physicians, in the state of		
11	Oregon. Thomas Harry Bray, MD (Licensee) is a licensed physician in the state of Oregon.		
12	2.		
13	On March 29, 2011, the Board issued an Interim Stipulated Order in which Licensee		
14	agreed to withdraw from active practice pending the conclusion of a Board investigation		
15	regarding allegations of criminal charges of sexual assault. On July 30, 2012, Licensee was		
16	convicted in a non- jury trial in Deschutes County on multiple criminal charges, to include two		
17	counts of Rape in the First Degree (Class A felony), two counts of Sodomy (Class A felony) and		
18	one count of Fourth Degree Assault and one count of Strangulation (Class A misdemeanors).		
19	Licensee was sentenced to 25 years of confinement by the Oregon Department of Corrections, as		
20	well as to fines and restitution.

23	ORS 677.225(1)(b) provides that a licensee's medical license is suspended automatically		
24	if the licensee is an inmate in a penal institution.

2	The license of Licensee to practice medicine is suspended, pursuant to ORS
3	677.225(1)(b). This suspension will remain in effect until Licensee presents satisfactory
4	evidence to the Board that Licensee is no longer incarcerated and the Board is satisfied with due
5	regard to the public interest that License's privilege to practice medicine may be restored.
