

Oregon Medical Board
BOARD ACTION REPORT
March 15, 2013

The information contained in this report summarizes new, interim, and final actions taken by the Oregon Medical Board between February 16, 2013 and March 15, 2013.

Scanned copies of Interim Stipulated Orders, Orders of Emergency Suspension, Stipulated Orders, Final Orders, Termination Orders, Modification Orders and Voluntary Limitations are included at the end of this report in the order that they appear in the report. These orders are marked with an * asterisk. **Scanned copies of Corrective Action Agreements and Consent Agreement are not posted, as they are not disciplinary action and impose no practice limitations.** Complaint and Notices of Proposed Disciplinary Action are not listed in this report, as they are not final actions by the Board. Both Orders, however, are public and are available upon request.

On March 5, 2013, Licensee entered into an Interim Stipulated Order to voluntarily withdraw from the practice of obstetrics pending the completion of the Board's investigation into her ability to safely and competently practice in this specialty. The Order also prohibits Licensee from prescribing or dispensing any controlled substances.

On March 7, 2013, Licensee entered into a Corrective Action Agreement with the Board. In this Agreement, Licensee agreed to a Board audit of her surgical cases after six months.

On March 7, 2013, Licensee entered into an Interim Stipulated Order to voluntarily withdraw from practice and expire his Limited License, Post Graduate. Licensee may re-apply for a Limited License, Post Graduate upon the completion of the Board's investigation into his ability to safely and competently practice medicine.

The Oregon Medical Board (Board) is the state agency responsible for licensing, regulating and disciplining certain health care providers, including osteopathic physicians, in the state of Oregon. Kathleen Marie Kleinert, DO (Licensee) is a licensed osteopathic physician in the state of Oregon and holds an active license.

2.

Licensee works as an osteopathic physician at a clinic in Springfield, Oregon. The Board received credible information which resulted in the Board opening an investigation of Licensee.

3.

In order to address the concerns of the Board while it conducts the investigation, Licensee and the Board agree to the entry of this Interim Stipulated Order, which provides that Licensee shall comply with the following conditions:

3.1 Licensee agrees to voluntarily and immediately refrain from providing obstetrical care.

3.2 Licensee is prohibited from prescribing or dispensing any controlled substances.

3.3 Licensee understands that violating any term of this Order may be grounds for disciplinary action under ORS 677.190(17), willfully violating Board order.

3.4 Licensee understands this Order becomes effective the date she signs it.

At the conclusion of the Board's investigation, the limitation placed on Licensee will be reviewed in an expeditious manner. If the Board determines, following that review, that these limitations shall not be lifted, Licensee may request a hearing to contest that decision.

This order is issued by the Board pursuant to ORS 677.265 while the Board conducts its investigation for the purpose of fully informing itself with respect to the performance or conduct of the Licensee and Licensee's ability to safely and competently practice medicine. Pursuant to ORS 677.425, Board investigative materials are confidential and shall not be subject to public disclosure, nor shall they be admissible as evidence in any judicial proceeding. However, as a stipulation this Order is a public document and is reportable to the national DataBank and the Federation of State Medical Boards.

The Oregon Medical Board (Board) is the state agency responsible for licensing, regulating and disciplining certain healthcare providers, including physicians, in the state of Oregon. Mark David Shelnut, MD (Licensee) is a licensed physician in the state of Oregon under a Limited License, Post Graduate.

2.

Licensee works as a resident at the Oregon Health & Science University. The Board received credible information regarding Licensee that resulted in the Board initiating an investigation. The results of the Board's investigation to date have raised concerns to the extent that the Board believes it necessary that Licensee agree to cease the practice of medicine until the investigation is completed.

3.

In order to address the concerns of the Board, Licensee and the Board agree to enter into this Interim Stipulated Order, which provides that Licensee shall comply with the following conditions effective the date this Order is signed by Licensee:

3.1 Licensee voluntarily withdraws from the practice of medicine and his Limited License, Post Graduate is expired effective the date this Order is signed by the Licensee. Licensee may reapply for a Limited License, Post Graduate upon the completion of the Board's investigation into his ability to safely and competently practice medicine.

1 3.2 Licensee understands that violating any term of this Order will be grounds for
2 disciplinary action under ORS 677.190(17).

4 At the conclusion of the Board's investigation, Licensee's status will be reviewed in an
5 expeditious manner. Following that review, if the Board determines that Licensee shall not be
6 permitted to return to the practice of medicine, Licensee may request a hearing to contest that
7 decision.

9 This Order is issued by the Board pursuant to ORS 677.265(1) and (2) for the purpose
10 of protecting the public, and making a complete investigation in order to fully inform itself with
11 respect to the performance or conduct of the Licensee and Licensee's ability to safely and
12 competently practice medicine. Pursuant to ORS 677.425, Board investigative materials are
13 confidential and shall not be subject to public disclosure. However, as a stipulation this Order is
14 a public document and is reportable to the national Data Bank and the Federation of State
15 Medical Boards.

17 This Order becomes effective the date it is signed by the Licensee.
