**STATE BOARD OF MEDICINE TAKES DISCIPLINARY ACTION**

**WAKEFIELD:** At its meeting yesterday, the state Board of Registration in Medicine took disciplinary action against the medical licenses of Corey J. Meyers, M.D., Michael S. Goldstein, M.D., Charlotte E. Hovey, M.D. and Roger Boshes, M.D.

The license of Dr. Corey J. Meyers was revoked. The Board found that Dr. Meyers' license to practice in New York was revoked by the New York Board for Professional Medical Conduct. Dr. Meyers is a 1993 graduate of the State University of New York Downstate Medical Center. He is board certified in Internal Medicine and has been licensed in Massachusetts since 1996. He is not currently practicing medicine.

The Board accepted the resignations of the licenses of Dr. Charlotte E. Hovey and Dr. Michael S. Goldstein. Resignation is a disciplinary action which permanently removes a physician from practice. Dr. Hovey is a 1977 graduate of Rush Medical College of Rush University. She is board certified in Radiology and has been licensed to practice in Massachusetts since 1998. She does not currently practice in Massachusetts. Dr. Michael S. Goldstein is a 1972 graduate of New York Medical College. He is board certified in Urology and has been licensed to practice medicine in Massachusetts since 1974. Dr. Goldstein is not currently practicing medicine.

Dr. Roger Boshes was found to have behaved inappropriately with a patient. Today the Board reprimanded him. Dr. Boshes is a 1976 graduate of Yale University School of Medicine. He is board certified in Psychiatry, and has been licensed in Massachusetts since 1981. He practices in Fall River.

The Massachusetts Board of Registration in Medicine licenses more than 40,000 physicians, osteopaths and acupuncturists. The Board was created in 1894 to protect the public health and safety by setting standards for the practice of medicine and ensuring that doctors who practice in the Commonwealth are appropriately qualified and competent.
