### Oregon Medical Board BOARD ACTION REPORT November 15, 2013

The information contained in this report summarizes new, interim, and final actions taken by the Oregon Medical Board between October 16, 2013 and November 15, 2013.

14	Licensee is board-certified in physical medicine and rehabilitation. The Board received				
15	credible information regarding Licensee that resulted in the Board initiating multiple				
16	investigations. The results of the Board's investigations to date have raised concerns to the				
17	extent that the Board believes it necessary that Licensee agree to certain terms until the				
18	investigations are completed.

20	In order to address the Board's concern, Licensee and the Board agree to the entry of this				
21	Interim Stipulated Order, which will remain in effect while these matters remain under				
22	investigation, and provides that Licensee shall comply with all of the following conditions:				
23	3.1 Licensee will not accept any new chronic pain patient into his practice and will				
24	not initiate chronic pain medications for any existing patient, effective the date the Licensee				
24	signs this Interim Stipulated Order. For the purposes of this Order, chronic pain is defined as				
25	pain that persists or progresses for more than thirty (30) days.

Licensee will facilitate the transfer of care for treatment of all his chronic pain 1 3.2 patients to new providers outside of his clinic within thirty (30) days of the effective date of this 2 3 Order. 4 3.3 Licensee will cease prescribing controlled substance medication for chronic pain thirty (30) days from the effective date of this Order. Licensee may authorize prescriptions for 5 6 pain medication for existing patients for no more than thirty (30) days, after the effective date of 7 this Order. Licensee may replace an existing pain medication with another controlled substance 8 on a dose equivalent basis, if the prior pain medication has intolerable side effects and/or is not 9 accessible to the patient. 10 3.4 No healthcare practitioner under Licensee's employment or associated with his clinic may authorize prescriptions for pain medications after 30 days from the effective date of 11

12 this Order.

13 3.5 Licensee may treat chronic pain patients with treatments other than controlled
14 substances.

3.6 Licensee understands that violating any term of this Order will be grounds for
disciplinary action under ORS 677.190(17).

17 3.7 Licensee understands this Order becomes effective at 5:00 pm on the date that he
18 signs this Order.

At the conclusion of the Board's investigation, the Board will decide whether to close the case or to proceed to some form of disciplinary action. If the Board determines, following that review, not to lift the requirements of this Order, Licensee may request a hearing to contest that decision.

This order is issued by the Board pursuant to ORS 677.410, which grants the Board the authority to attach conditions to the license of Licensee to practice medicine. These conditions will remain in effect while the Board conducts a complete investigation in order to fully inform
