WHEREAS the State Board of Medical Examiners (the Board) has received an initial complaint of misconduct with respect to Ranjini Pillai, M.D. (Respondent), regarding allegations of professional misconduct; and

WHEREAS, the Board is prepared to serve and file a Notice and Formal Complaint, charging Respondent with violations of, *inter alia*, S.C. Code Section 40-47-110 which provides, among other things, that the Board may revoke, suspend, or otherwise restrict the license of a licensee upon a finding of misconduct; and

WHEREAS, Respondent has advised that she wishes to waive further proceedings and give up forevermore the right to practice medicine in South Carolina; and

WHEREAS, Respondent understands that she has the right to a hearing and to be represented by counsel in this matter. Respondent is represented by counsel. Respondent understands and agrees that by entering into this agreement she voluntarily relinquishes any right to judicial review. Respondent freely, knowingly, and voluntarily waives any and all such rights and further proceedings in this matter. Respondent understands and agrees that she will not be eligible to reapply for a license to practice medicine in this State in the future. Respondent understands and agrees that, once signed, this Agreement is irrevocable on her part and shall not be subject to judicial review; and

WHEREAS, it is understood and agreed that, pursuant to the South Carolina Freedom of Information Act, this is a public document.

THEREFORE, Respondent does hereby agree to relinquish forevermore her right to practice medicine in South Carolina, effective immediately upon acceptance by the Board.
